

NO RESIDENCE REQUIREMENTS




COMMONWEALTH CITIZENSHIP


St. Kitts & Nevis citizens are entitled to special privileges across the British Commonwealth, including the UK.

Applicant Requirements

- Applicants must pass due diligence in order to apply for the programme.
- Applicants must not have a criminal record.
- Applicants must be in good health.


