- Applicants must pass due diligence in order to apply for the programme.

- Applicants must be proficient in English at Level B, 4.0 for the Skilled Business Worker Visa Programme and obtain a score of 5.5 across each category of IELTS for the Isle of Man Innovator Visa Programme.





## PROGRAMME DETAILS

### Isle of Man Innovator Visa Programme

The Isle of Man is one of the British Isles located on the Northwest coast of England. The island holds close links to the whole of the United Kingdom. Many business people live in the Isle of Man daily commute to the UK (London 70 minutes, Liverpool 40 minutes, Birmingham 55 minutes).

The Isle of Man Innovator Visa is a 3-year programme designed for experienced entrepreneurs seeking to establish a business in the Isle of Man, collaborate with an existing company through investment, or become involved in the management of a business. Key advantages include a pathway to permanent residency in just 3 years and eligibility for a passport in 4 years, up to 100% shareholding, free education and healthcare, and a separate taxation system from the UK, featuring income tax rates starts at 10% (lower than the UK) and a 0% corporation tax rate.

The programme offers three different options:

- 1. INNOVATIVE BUSINESS SET-UP**  
Requires a minimum of GBP 50,000 in your bank account, with an innovative business idea.
- 2. PASSIVE INVESTOR**  
Requires a minimum investment of GBP 150,000 in an existing business as a silent partner.
- 3. ACTIVE INVESTOR**  
Requires a minimum investment of GBP 200,000 with full involvement in the business.



## PROGRAMME DETAILS

### Skilled Worker Business Visa Programme

The Skilled Worker Business Visa is a 5-year programme designed for individuals looking to set up or expand a business in the UK. By establishing a UK company that sponsors your visa, you can live and work in the UK as your own boss, without needing to invest or work for another company. This route can lead to permanent residency for you and your family after 5 years, with eligibility for a UK passport after 12 months of permanent residency.

To qualify, applicants need a minimum GBP 50,000 in business running costs, ready for immediate transfer to a UK Business Bank Account, an IELTS score of 4.0 across each category, relevant business experience, and a UK resident to act as a director for up to 12 months. Additionally, applicants must stay in the UK for at least 180 days per year to maintain the visa.
