- Applicants must pass due diligence in order to apply for the programme.
- Applicants must not have a criminal record.
- Applicants must be in good health.





PROGRAMME OPTIONS

There are two different options to acquire citizenship through the Vanuatu Citizenship Programme. Applicants can secure their passports within 2-3 months, granting visa-free access to over 100 countries, including Hong Kong, Singapore and numerous other strategically significant destinations. Applicants may choose one of the following two options:

Government Contribution Programme:

- A non-refundable contribution to the Development Support Program starting at USD 130,000.
- A minimum non-refundable contribution of USD 165,000 to a Coconut Biofuel fund.

Government Bond Programme:

- A minimum investment of USD 100,000 in a Vanuatuan Government Bond, retrievable after 3 years with 0% interest.



VANUATU CITIZENSHIP BY INVESTMENT PROCESS

8. Government contribution is paid.
9. Passport of Vanuatu is issued.
